# TRAINING ADMINISTRATOR

I am aware of only one new course - Helen Hooker is running a technique day for Essex on 24 March.

I am getting feedback that branches are reluctant to organise full days as extra to their normal programmes. I would suggest that we offer half day workshops as well, so that branches can have the tutor for a whole day as part of their normal playing cycle, but have the workshop in the morning. This will be difficult with the intermediate conducting course, but should be possible with the others. If the committee agrees, I will approach the tutors for their agreement and email/write to branches to this effect.

I wish to propose that the fee should rise to £60 for a half day, £120 for a whole day.

### Instrument loan

NYRO has 2 instruments (1 great bass and 1 contrabass) donated by Jeanette Hipsey. They were serviced by Kung in 2006 and are now in excellent condition. Apart from the NYRO summer course and concert they are available for use by other groups. It is of course desirable that resources such as these be fully used. Also loans relieve NYRO of the need to store them, an issue that will become more difficult as the number of instruments increases. In the past two years quick *ad hoc* decisions have been made. The NYRO subcommittee now proposes a fairer procedure.

The instruments will be offered for loan preferentially to SRP-affiliated orchestras or SRP branches from September to June. There will be a charge of £100 per instrument. Transport costs will be met by the borrowers. They may be recalled temporarily for NYRO playing days or short courses. Applicants will submit a written case for evaluation by the NYRO subcommittee in case there are competing applications. If no applications are received from preferred groups, instruments may be loaned to other organisations on similar terms but at a cost of £150. Availability and closing date will be notified to orchestras and branches and posted on the SRP website.

# **Instrument purchase**

Orchestras require more bass instruments. The musical requirement for NYRO is 6 great basses and 4 contrabasses, for NYTRO 3 great basses and 2 contrabasses, plus spares. Purchase of one instrument per year would average about £2500 and take about 18 years to complete. NYRO proposes to start such a programme and build the cost into the annual budget. Donations and loan fees would be allocated to the instrument fund. This will give a focus to fundraising with the possibility of individually sponsored instruments. Purchased instruments will be offered for loan as are the current instruments. Makers (such as Kung, Paetzold and Dolmetsch) and shops will be invited to tender as preferred suppliers for the acquisition programme.

The programme will accelerate if other funding can be obtained. It has regularly been suggested at Conference that the SRP buy instruments for loan. If the Committee agrees to do so, loans, servicing etc. could be managed by the NYRO subcommittee in the same way as the current instruments. If a separate management is preferred, we suggest that there be a commitment to make SRP-owned instruments available to NYRO for the main course and concert in the summer. This would acknowledge SRP ownership and support of NYRO and would be a reasonable *quid quo pro* for the preferred loan of NYRO instruments to SRP groups. Any policy for charging, also ideally the purchasing policy, should be consistent for SRP and NYRO instruments.

The deficit for the year was £1530 leaving the fund at £24,681 on the 31<sup>st</sup> August. I anticipate a further shortfall of £500 for the current year.

Subscription income fell by £881 compared with 2004/05 and subscriptions for 2004/05 were £460 less than 2003/04. The cost of the Annual Conference rose by almost £350, the cost of conductors' visits remained the same, though it appears that one branch hasn't claimed yet (their claim will put up the cost by about £100). Committee expenses were down by £760 due to holding one of the meetings immediately after the Conference.

The Walter Bergmann Fund received £1,159 in donations, and £1,822 share of bank interest. It made grants totalling £5,575 and donated £180 to sponsor a concert for the ERTA conference in 2005. The year's loss was £3073 leaving its fund at £41,264.

I separated the NYRO accounts from the Arthur Ingram Fund for the 2004/5 accounts as NYRO has its own treasurer and bank account. It also makes the accounting for the Arthur Ingram Fund easier; the fund received £6961 share of bank interest, £20 in donations, and £7 in royalties. Its main expenditure was the NYRO management fee (£1000 still owed for 2005, £4000 for 2006 course), a grant towards a David Munrow memorial composition, and workshops (£560, minus £410 entrance fees) £150. For the current year the NYRO management fee will be £6000.

In view of the deficit for the year 2004-05, 2005-06 and quite possibly for the current year I would recommend to accept last year's suggested increase in subscription rates from September 2007. This means the rates would rise to / or for those who have already accepted the higher

rates remain at £17.50 per full member, £28.00 per household membership and £13.00 for students. I am very grateful that several branches have already opted to pay the recommended increased rate from September 2006.

I would also like to ask that branch accounts, Competition account report and NYRO accounts should get to me in mid-November wherever possible to give me sufficient time to consolidate all accounts, present them to the Independent Examiner and be able to send them to the Charity Commission as early as possible (this may influence access to funding) as well as making sure they are completed in time for the Conference. – I intend to modify the standardised form for branch account returns to encourage its use – I hope to have this ready in time for the Conference. – I request that Warwickshire falls in line with the SRP financial year (1st September to 31st August); and further that pastoral visitor's travelling expenses be claimed before the end of the financial year in which they take place.

I wish to thank Keith Varney, our Independent Examiner, for his helpful advice and efficient handling of the auditing of the Society's accounts.
