Subscription income rose by about £400 compared with 2010/11. The cost of the Annual Conference was £4,865, £360 less than in the previous year, the cost of conductors' visits was £3,040, down £100; committee expenses went up by about £1,090 (£4,650). A year without membership list keeps the printing cost low. Overall the loss (£940) was less than I had anticipated due to higher income and lower expenditure. I find it difficult to predict the cost of the forthcoming conference in Ireland in May. If attendance at the conference (and the festival) is low the actual conference cost may not be very high but we may find that we may have to pay up for a loss making festival.

I wonder whether I should separate the cost of committee members attending conference from the cost of branch delegates and musical advisers, and add committee members' cost to the committee expenses.

The **Walter Bergmann Fund** received £1,585 in donations, and £236 share of bank interest (15.88% of total), £236 in Gift Aid, £272 from festival surplusses, and £14 in royalties. It made grants totalling £9,720, provided the SRP/Moeck competition  $3^{rd}$  prize (£300) and spent £68 on committee expenses. The year's shortfall was £7,628 leaving its fund at £30,178 on  $31^{st}$  August 2012.

The **Arthur Ingram Fund** received £1,078 share of bank interest (72.27% of total) and £4,300 in Gift Aid. Its main expenditure was the NYRO management fee (£6,600), support of festival music (£485) and workshops (£1350). The cost of the **competition** was £1450. Expenditure on the Brian Bonsor CD amounted to £1960 in 2011/12. We also gave a grant to the Dolmetsch conference of £500 out of the Arthur Ingram Fund and spent £270 on digitalisation of documents. The overall expenditure of the Arthur Ingram Fund amounts to £14,375, a loss of £8,294. The overall fund amounts to £164,141 on  $31^{st}$  August 2012.

This year I have changed the percentage of allocating bank interest to the different funds to reflect the sums held in each fund at the present time. I had kept the previous percentage the same since taking over as treasurer in 2006.

Looking at the current year I predict a loss of £3,800 for the central fund. I would like to propose a small increase in subscription in order to prevent a large increase of subscriptions subsequently. A £1 increase in subs, 50p for students should be acceptable to most. While it will not cover the predicted loss it will at least slow it down and the past year showed that I tend to be careful with predicting income, or overestimate expenditure.

Most branches sent me their accounts by middle of October, some still hadn't realised the earlier deadline. There is a continuous problem with branches not being aware of the necessity to use last year's final figure as starting point and the necessity to record payments from other SRP accounts clearly, making my cross checks at times quite difficult; this also applies to workshops that should be neutral to branch accounts. The NYRO accounts were again examined by our Independent Examiner, this has proved very helpful in consolidating the accounts. I wish to thank Keith Varney, our Independent Examiner, for his helpful advice and efficient handling of the auditing of the Society's accounts.

#### Walter Bergmann Fund Report

The committee meets three times a year following the deadlines for applications as posted on the SRP website.

For the meeting in the week beginning 4<sup>th</sup> February there were six applications for funding of which two were approved in full, two partially funded and two rejected.

The two approvals were for the purchase of two recorders for a teenager, and for the London Borough of Havering to run a Recorder Day with professional players.

The partial fundings were for two people to participate in the ensemble *Take Note*, but not to pay for private lessons.

The two rejections related to applications from music students who requested funds for buying instruments with insufficient - or no - financial information given.

Since last May, £1445 has been given to the fund through sales of music and instruments all of which has gone through committee members. There are currently a number of instruments which are being sold and I have a large pile of music which I am selling through visits to branches and courses that I run.

### **Moeck/SRP Competition Report**

Since the last Committee meeting the 2011 First Prize Winner's Recital has taken place at the Royal International Greenwich Festival and Exhibition last November. This was an excellent and well attended recital confirming the importance and standing of the Competition. It is estimated that the audience was between 250 and 300.

The recital was preceded in the morning with the BBC Radio 3's live broadcast of the Early Music Show. This featured Eva Fegers and Charlotte Barbour-Condini. The Society's support for the Competition was mentioned on several occasions.

The Exhibition dates were moved for the first time last year from Friday, Saturday, and Sunday to Thursday, Friday and Saturday. It is felt that this enhanced the numbers attending the recital. The only downside was that the Chapel was being used for the whole of the Saturday morning by the BBC and Eva Fegers had little rehearsal time in the Chapel. However facilities were provided by Trinity-Laban College, which were entirely satisfactory.

Publicity Material for the 2013 Competition has been sent to all UK Musical Colleges and to all Universities with Music Departments. It has also been sent to all the Colleges in Ireland, both in the Republic and in Northern Ireland. Much work has been undertaken to provide information to colleges in continental Europe and beyond. This list could be extended for future competitions.

As a result of the  $75^{\text{th}}$  anniversary Celebration a representative of Moeck attended the Competition for the first time for a number of years. Following a representation to Jan Haase the First Prize has been increased to £1,500 for 2013. Moeck will expect to have an increased presence at the Competition details of which remain to be discussed with both Moeck and the Early Music Shop. Some preliminary work on trying to secure additional recitals for the prize winner has been started, but so far without anything definite to report.

Finally I would like to thank both Heather Sager and Peter Booth for all the help they gave in organising the recital last year. Their continuing support is incalculable.

## NYRO Sub-Committee Report

The Minutes of the subcommittee meeting on 26 November 2012 are forwarded for the information of the committee [see separate document]. Members of the subcommittee are very regretful that the SRP committee wishes to end the position of NYRO as a part of the SRP, which we believe to have been an important part of the SRP charitable purpose. Because of another engagement I am unable to be present at the Annual Conference in 2013 but nevertheless I would suggest that a decision of this importance should be discussed by delegates at the Annual Conference and I hope that provision would be made for such a discussion.

Since the last meeting there has been one Taster Day in Hatfield, jointly with Hertfordshire Music Service. There were 12 paying players (fewer than the previous year). The income of  $\pounds 300$  was shared with Hertfordshire, resulting in a cost to NYRO of  $\pounds 248$ . However, one of the young boys took a fancy to the great bass and has borrowed one for the year, in return

for the usual contribution of £100. Dates for future Taster Days in Oxford, Exeter, London and Edinburgh have recently been arranged and bookings have started to come in, also for the Easter and Summer residential courses.

Income this year so far is  $\pounds$ 7,231, of which  $\pounds$ 3000 is from the SRP and  $\pounds$ 2,500 from the parent donor. The remaining  $\pounds$ 2,500 from the donor has not yet been received. Excluding such donations the income is  $\pounds$ 1,503, principally fees in advance for playing days and residential courses. Expenditure is  $\pounds$ 734. The bank balance at present is  $\pounds$ 7,807.

The next subcommittee meeting will be on 22 February 2013. As well as planning for the next year's activities, we shall be drafting a constitution based on a model provided by the Charity Commission for England and Wales as a Charitable Incorporated Organisation (CIO), with the intention of applying in due course to the Charity Commission for that status. We have been promised informal advice from a NYRO parent with legal qualifications.

I am pleased that Naomi Wellings has agreed to succeed me as NYRO Chair with effect from 1 September 2013 and I should like that nomination to go to the Annual Conference for ratification.
